We agree to develop characteristics that will benefit and enhance our marriage, including but not limited to kindness, patience, forgiveness, respect, trustworthiness, loyalty, helpfulness, courtesy, communication skills, self-reliance, temperance, financial temperance, and a strong work ethic;
- 11. We agree to take all reasonable efforts to remove characteristics from ourselves that we find injurious to our marriage by participating in counseling, classes, or any other help designed to address the behavior that is proving injurious before the marriage is irreparably harmed;
